Dear Secretary Bose:

On May 10, 2022, Golden Spread Electric Cooperative, Inc. (“Golden Spread”) submitted for filing its first Order No. 676-J compliance filing and an associated request for waivers in this proceeding (“May 10 Filing”). That filing included a new proposed version of Attachment S - NAESB WEQ Standards to Golden Spread’s Open Access Transmission Tariff. After informal discussion with Commission Staff, Golden Spread determined that its May 10 Filing did not specifically address Parallel Flow Visualization (“PFV”) requirements set out in revisions to WEQ-008 - Transmission Loading Relief (TLR) - Eastern Interconnection (WEQ Version 003.3, March 30, 2020). In addition to the cybersecurity requirements, the specific PFV requirements addressed within the changes to WEQ-008 were to be included as part of a utility’s first Order No. 676-J compliance filing, as discussed in Paragraphs 49-50 of Order No. 676-J.

Golden Spread has historically requested and received waiver from the Commission of the requirement to include the entirety of WEQ-008 of the NAESB WEQ Standards in its Attachment S. Waiver was appropriate because Golden Spread’s transmission facilities remained limited and discrete, (2) those facilities did not constitute an integrated transmission system and (3) it does not operate a balancing authority. Moreover, the Commission consistently granted Golden Spread waiver of the requirement to establish and maintain an OASIS, and the Commission also granted Golden Spread waiver of the Eastern Interconnection TLR Procedures. The most recent waiver of WEQ-

008 (WEQ version 003.2) was received in *Golden Spread Electric Cooperative, Inc.*, 178 FERC ¶ 61,160 at Para 17 and fn 28 (2022), as part of Order No. 676-I compliance. No circumstances have changed to merit a different conclusion. In its May 10 Filing, Golden Spread requested continued waiver of WEQ-008, but as noted above did not reference version 003.3 in its tariff records.


Accordingly, to correct the tariff records associated with its May 10 Filing, Golden Spread hereby submits a new tariff record for Attachment S. The sole change is to reflect the newest version of WEQ-008 (WEQ version 003.3) in the section in which waiver is requested. This change is intended solely to incorporate by reference the PFV requirements contained therein, with the remaining changes to WEQ-008 included in the second phase of Order No. 676-J compliance, which was made by Golden Spread in October 2022 in Docket No. ER23-207-000. As before, Golden Spread includes an effective date of 12/31/9998 in its eTariff records, as specified in Order No. 676-J.
